### Location

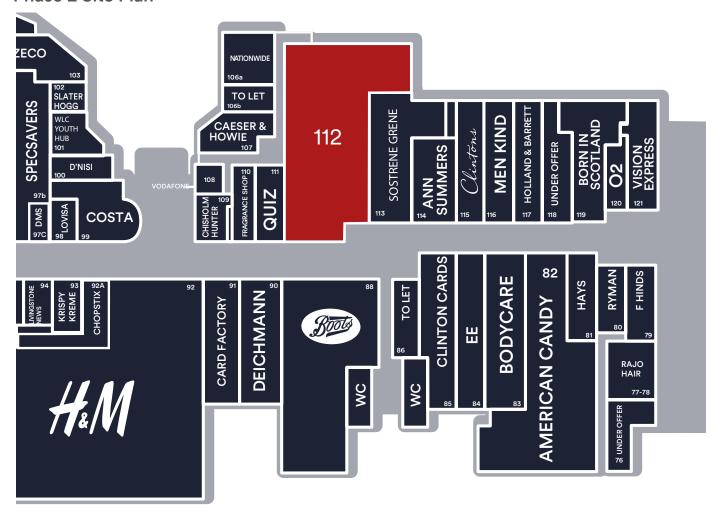
