DESCRIPTION

Boston Shopping Park is a well-established retail destination located on Horncastle Road, Boston, PE21 9BD, just one mile northeast of Boston town centre.

The park offers a vibrant mix of national retailers including TK Maxx, Sports Direct, The Food Warehouse, and Home Bargains, making it a key shopping hub for the local community.

The site comprises approximately 104,916 sq.ft of ground floor retail space across eight units, with flexible layouts suitable for a variety of retail formats.

Access to the property is via Horncastle Road, between the units of The Food Warehouse and Easy Bathrooms which then leads to the car park and access to the rest of the retail units.

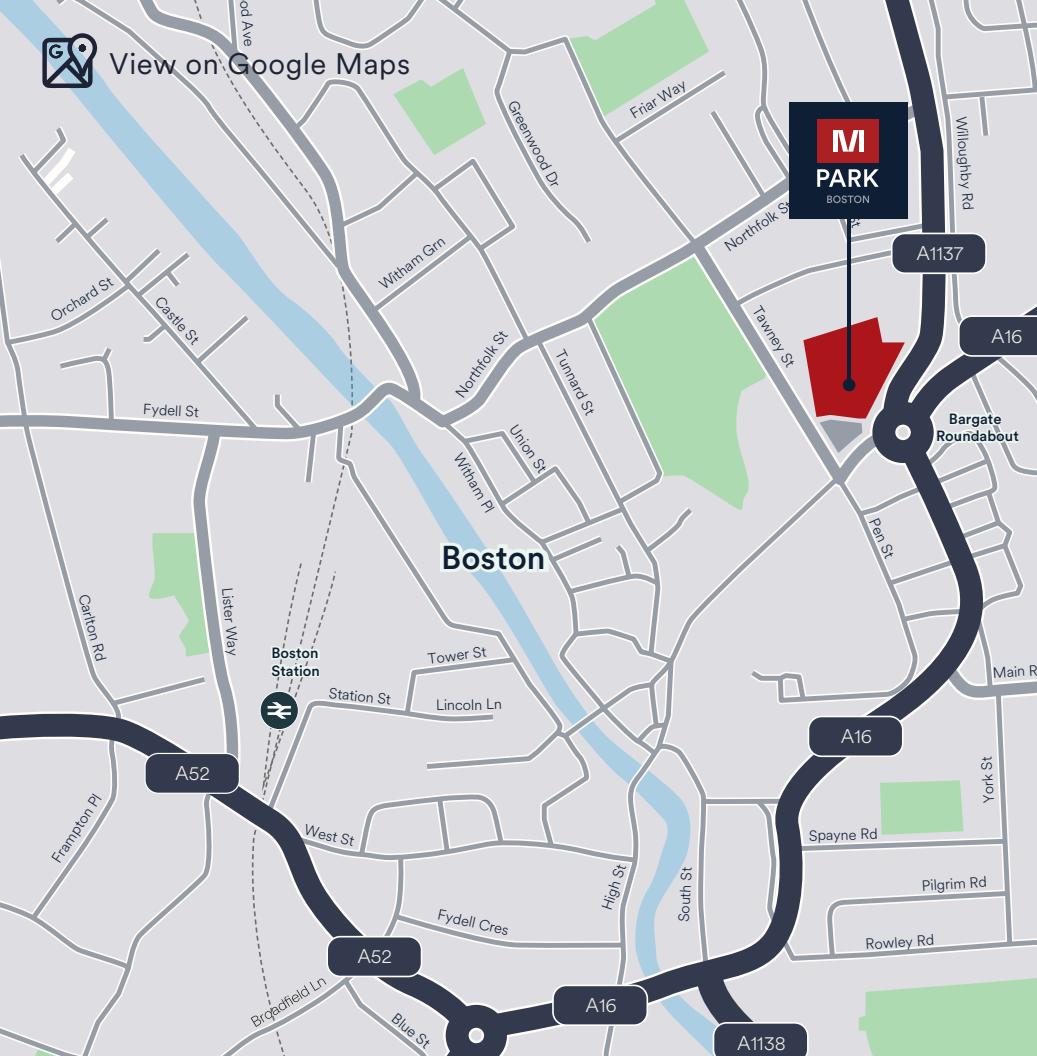
