## DESCRIPTION

Arbroath Road comprises of an 'L' shaped row of single storey individual retail units, of steel-framed construction with metal cladding, glazed frontage, and rear service access doors. This retail parade, developed by Aldi, boasts extensive on-site car parking and excellent servicing facilities.

The retail units are situated on the eastern side of the city and are easily accessible from the main roundabout linking Arbroath Road to the A92 and A972/190 Kingsway, Dundee's principle ring route. Dundee, with a catchment population of some 235,000, represents Scotland's fourth largest city and is the regional centre for employment, servicing and retailing within the Tayside region.
